

ORDINANCE NO. (O)21-10

AN ORDINANCE OF THE TOWN OF ORO VALLEY, ARIZONA, AMENDING ORO VALLEY TOWN CODE SECTION 11-3-4, "SPEED LIMITS", SUBSECTIONS Q, X AND ADDING SUBSECTION Y; REPEALING ALL RESOLUTIONS, ORDINANCES, AND RULES OF THE TOWN OF ORO VALLEY IN CONFLICT THEREWITH; PRESERVING THE RIGHTS AND DUTIES THAT HAVE ALREADY MATURED AND PROCEEDINGS THAT HAVE ALREADY BEGUN THEREUNDER

WHEREAS, the Town of Oro Valley is a political subdivision of the State of Arizona vested with all associated rights, privileges and benefits and is entitled to the immunities and exemptions granted municipalities and political subdivisions under the Constitution and laws of the State of Arizona and the United States; and

WHEREAS, on September 27, 1989, the Town Council did approve Ordinance Number (O) 89-21, which adopted that certain document entitled, "Oro Valley Town Code, Chapter 11, Traffic; Motor Vehicles," as the eleventh chapter of the official Town Code; and

WHEREAS, pursuant to Oro Valley Town Code Section 11-3-3, "Traffic Control Devices," the Town Engineer or Chief of Police with the approval of the Town Council shall place and maintain traffic control devices deemed necessary to regulate traffic under the traffic laws of the Town and the State of Arizona; and

WHEREAS, The Department of Public Works in partnership with the Police Department, working in conjunction with the Town's internal Traffic Safety Committee, have studied the current traffic and speed conditions of Moore Road, and request that the Town Council adjust Oro Valley Town Code Section 11-3-4, "Speed Limits"

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the Council of the Town of Oro Valley as follows:

SECTION 1. Oro Valley Town Code Section 11-3-4, "Speed Limits", shall be amended to read as follows, with additions in all CAPS and deletions in ~~strikethrough text~~:

Section 11-3-4 Speed Limits

...

~~Q. Moore Road from Rancho Vistoso Boulevard to the Town's western boundary: 35 miles per hour.~~ MOORE ROAD FROM RANCHO VISTOSO BOULEVARD TO EAGLEVIEW DR.: 35 MILES PER HOUR. MOORE ROAD FROM EAGLEVIEW DR. TO THE ROUNDABOUT AT LA CANADA DRIVE: 45 MILES PER HOUR. MOORE ROAD FROM THE ROUNDABOUT AT LA CANADA DRIVE TO 1000FT WEST: 35 MILES PER HOUR. MOORE ROAD

FROM 1000FT WEST OF THE ROUNDABOUT TO THE TOWN'S WESTERN BOUNDARY: 45 MILES PER HOUR.

X. ~~All other streets, roads and areas: 25 miles per hour.~~ TRAFFIC ROUNDABOUT WHICH FORMS THE INTERSECTION OF LA CANADA DRIVE AND MOORE ROAD: 15 MILES PER HOUR.

Y. ALL OTHER STREETS, ROADS AND AREAS: 25 MILES PER HOUR.

SECTION 2. That the Town Manager, Town Clerk, Town Legal Services Director, Town Engineer, Chief of Police or their duly authorized officers and agents are hereby authorized and directed to take all steps necessary to carry out the purposes and intent of this Ordinance.

SECTION 2. All Oro Valley Ordinances, Resolutions, or Motions and parts of Ordinances, Resolutions, or Motions of the Council in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.
